RE: MECA Tariff M.P.S.C. No. 23R Local Transport and Termination Services (LTTS) TAM Transmittal No. 14

Enclosed is one copy of MECA's Tariff M.P.S.C. No. 23R revisions for filing with the Commission pursuant to Public Act 179 of 1991, as amended, MCL 484.2101 et seq. and the May 18, 2016 letter from the Commission Staff.

This filing modifies Parts I & VI (LTTS) to reflect revisions to the reciprocal compensation rates in compliance with FCC Rules 51.705(c)(3) and 51.909(f) for these companies: Ace Telephone Company of Michigan and Ace-Old Mission Exchange, the former Allendale Communications (now merged into Ace Telephone Company of Michigan), Baraga Telephone Company (OCN 0675 and OCN 4253), Barry County Telephone Company, Blanchard Telephone Company, Bloomingdale Telephone Company, Carr Telephone Company, Chapin Telephone Company, Deerfield Farmers' Telephone Company, Drenthe Exchange of former Allendale Telephone Company (now merged into Ace Telephone Company of Michigan), Hiawatha Telephone Company, Kaleva Telephone Company, Lennon Telephone Company, Midway Telephone Company, Ogden Telephone Company, Ontonagon Telephone Company, Pigeon Telephone Company, Sand Creek Telephone Company, Southwest Michigan Communications, Inc.., Springport Telephone Company, Waldron Telephone Company, Westphalia Telephone Company, Winn Telephone Company, and Winn Telecom (OCN 0127).

FCC Rule 51.705 (c)(3) requires that no carrier's Non-Access Reciprocal Compensation rate shall exceed the carrier's tariffed interstate access rate in effect in the same year for the equivalent functionality.

FCC Rule 51.909(f) requires that beginning July 1, 2016, each Rate-of-Return (ROR) carrier shall establish terminating End Office Access Services rates such that its Terminating End Office Access Service Rate does not exceed \$.005 per minute. FCC Rule 51.909(f) further provides that such ROR carrier's intrastate terminating end office access rates may not exceed the comparable interstate terminating end office rates.

For purposes of these rates, pursuant to FCC Rule 51.903(d), End Office Access Service means the local switching rate element for ROR carriers whose LTTS rates are disaggregated into 3 rate elements, or the single LTTS rate for those ROR carriers which have not disaggregated their LTTS rate.

This tariff filing reduces the applicable local switching rate element to \$.005 (for ROR carriers with disaggregated LTTS rates) and the LTTS to \$.005 per minute, for ROR carriers with an aggregated rate, respectively.

Also, the filing disaggregates the LTTS rate for Chapin Telecom Company and Winn Telecom OCN0127 into 3 rate elements.
