RE: Great Lakes Comnet, Inc.'s Tariff M.P.S.C. No. 25(R)/TAM Transmittal No. 3

Enclosed is one copy of Great Lakes Comnet's Tariff M.P.S.C. No. 25(R) revisions for filing with the Commission pursuant to the Michigan Telecommunications Act (MTA), Public Act 179 of 1991, as amended, MCL 484.2101 et seq.

This filing reduces the intrastate switched access rates for certain rate elements for Deerfield Farmers' Telephone Company (DFTC) (OCN 558A) which is an issuing carrier under Great Lakes Comnet's Tariff M.P.S.C. No. 25(R) pursuant to the requirements of MTA Section 310(2) that CLECs phase down their intrastate switched access rates to interstate rate levels by January 2015. You will note that the rates for certain rate elements either (1) were unchanged because tariff revisions made earlier in 2012 took the rates to the required rate levels or (2) were increased because the rates "mirrored" increases in the corresponding interstate switched access rate elements set forth in Tariff F.C.C. No. 20.

As indicated in my January 4, 2013 letter, TAM has taken over the administration of Great Lakes Comnet's Tariff M.P.S.C. No. 25(R), and other tariffs. Great Lakes Comnet's M.P.S.C. Tariff No. 25(R) can be viewed in its entirety at <http://telecommich.org/news/?newsid=245>.

The effective date of these changes is January 1, 2013.
