RE: Great Lakes Comnet, Inc.'s Tariff M.P.S.C. No. 25(R)/TAM Transmittal No. 7 Climax (CTC) (OCN 8331)

Enclosed is one copy of Great Lakes Comnet's Tariff M.P.S.C. No. 25(R) revisions for filing with the Commission pursuant to the Michigan Telecommunications Act (MTA), Public Act 179 of 1991, as amended, MCL 484.2101 et seq.

This filing reduces the intrastate switched access rates for certain rate elements for the above-referenced company pursuant to the requirements of MTA Section 310(2). You will note that the rates for certain rate elements either (1) were unchanged because tariff revisions made earlier took the rates to the required rate levels or (2) were increased because the rates "mirrored" increases in the corresponding interstate switched access rate elements.

Also enclosed is a spreadsheet which set forth the information supporting the intrastate switched access rate changes set forth in this transmittal.

The effective date of these changes is January 1, 2014.
