



# LOCAL TELEPHONE EXCHANGE SERVICE DIRECTORY LISTINGS

#### A. GENERAL

- 1. Directory Listing regulations apply to listings in the regular alphabetical list of names of customers, commonly referred to as "white pages".
- 2. A single listing in the alphabetical section of the directory is provided to a customer without extra charge. Listings are intended primarily for the purpose of identification and are limited to information which is essential to such identification. Directories are furnished and the Telephone Company reserves the right to refuse to insert any listing in its directories which does not facilitate directory service.
- 3. The length of any listing is limited to one line by the use of abbreviations when the clearness of the listing and the identification of the customer are not impaired thereby. When more than one line is required to properly list the customer, no additional charge is made.
- 4. The Telephone Company will refuse to list in the alphabetical section of the telephone directory any listing which does not constitute a legally authorized and adopted name, and/or any name which is likely to mislead or deceive the public as to the identity of the customer, or consisting of figures and symbols, or which is inserted for advertising purposes, or which is more elaborate than is reasonably necessary to identify the customer. The Telephone Company will withdraw any listing which is found to violate the above rule.
- 5. When a customer contracts for more than one individual line of the same class and at the same location, consecutive telephone numbers may be assigned to such lines and in such cases the use of more than one listing is unnecessary for the efficient handling of the service.
- 6. Upon written request, a customer's listing may be omitted from the directory, Connection with such non-published stations are completed only when requested by telephone number.

#### **B. BUSINESS LISTING**

- 1. A listing must be the name of the individual, partnership, corporation, firm, association, institution etc., to whom service is furnished; or the name of a member, officer, employee or representative thereof; or the name of another business house which the customer represents; controls or owns. Listings other than those specified herein are available only in connection with Joint User Service.
- 2. The listing of a service, commodity or trade name such as "Coal; 237 W. 5th Street; 346-5376:" appearing in the sequence of alphabetical names is not permitted.
- 3. When a customer is engaged in more than one line of business, only the business by which he is best known will ordinarily be included in the business designation.
- 4. Double name listings or the use of titles such as "Pres.", "V-Pres.", "Mgr.,", etc., are not permitted for example, "Paramount Supply Co., John Drake, Manager; 243-4365.
- 5. Listings of telephones in churches will not include in the same listing the name of the church and also that of its pastor or of organizations or societies associated therewith.
- 6. A caption listing for example, the listing Mason ic Temple under which is indented Auditorium, Banquet Room, Chapter Floor, each with telephone number is provided only if necessary for the efficient use of the service; no additional charge is made for the caption listing. The caption must be of an essential part of the listings which follow. The names of individuals are not inserted under a caption, but will be shown in their proper alphabetical sequence in the directory. Indented listings which do not materially add to the information contained in the caption or which are designed to advertise the extent of the customer's business are not permitted.

#### C. Initial Contract Period and Termination Charges

a. Initial Contract Period

The initial Contract Period is five years starting with the date service is established. A five-year contract applies to: (1) initial and addition al DID Central Office Number Capacities and (2) initial trunk capacity for the initial establishment of service.

- b. Termination Charges
  - (1) The termination charge is equal to 50% of the monthly charges for the unexpired period of the contract, based on the rates in effect at time service is established.
  - (2) Termination charges are applicable in the event of:
    - (a) Complete discontinuance of service by the customer or by the Company as specified in Tariff M.P.S.C. No. 7.
    - (b) For discontinuance of service because the customer refuses to subscribe for adequate facilities as in A.8.(a) preceding.
  - (3) Cancellation of a contract after the installation of the required equipment and facilities is completed, but before the service is established, a termination charge is applicable in (1) above.
  - (4) Cancellation of a contract before installation is completed, a charge consisting of the loss on equipment and facilities in the process of building or being installed, the installation labor, the labor cost of removal and other expenses not to exceed the termination charges is applicable.

#### 3. Central Office Trunks

- (1) Central office trunk charges are as specified in Tariff M. P.S.C. No. 1 for the exchange in which the customer is located.
- (2) The Local Service Area Calling privileges are as specified in the exchange from which service is provided.

#### C. Initial Contract Period and Termination Charges

#### a. Initial Contract Period

The initial Contract Period is five years starting with the date service is established. A five-year contract applies to: (1) initial and addition al DID Central Office Number Capacities and (2) initial trunk capacity for the initial establishment of service.

#### b. Termination Charges

- (1) The termination charge is equal to 50% of the monthly charges for the unexpired period of the contract, based on the rates in effect at time service is established.
- (2) Termination charges are applicable in the event of:
  - (a) Complete discontinuance of service by the customer or by the Company as specified in Tariff M.P.S.C. No. 7.
  - (b) For discontinuance of service because the customer refuses to subscribe for adequate facilities as in A.8.(a) preceding.
- (3) Cancellation of a contract after the installation of the required equipment and facilities is completed, but before the service is established, a termination charge is applicable in (1) above.
- (4) Cancellation of a contract before installation is completed, a charge consisting of the loss on equipment and facilities in the process of building or being installed, the installation labor, the labor cost of removal and other expenses not to exceed the termination charges is applicable.

# AUXILIARY SERVICES AND EQUIPMENT BLOCKING SERVICE

#### A. GENERAL

- 1. Blocking service provides residence and business customers with the ability to block access from a particular network access line to all telephone numbers for which a certain Numbering Plan Area (NPA) or prefix must be dialed.
- 2. The two types of Blocking Service available are 900 Blocking Service and 976 Blocking Service.
  - a. 900 Blocking Service blocks access to all telephone numbers for which the 900 NPA must be dialed.
  - 976 Blocking Service blocks access to all telephone numbers for which the prefix 976 (1+NPA+976 or 1+976) must be dialed.
- The service is classified as a local exchange telecommunications service.

#### **B. CONDITIONS**

- 1. The Company's obligation to furnish network facilities for Blocking Service is dependent upon the availability of suitable facilities. Because of central office and other facility limitations, it may not be possible for the Company to provide all of the services that may be requested.
- 2. Blocking Service is available only for blocking access to all 900 NPA or 976 prefix telephone numbers from a particular network access line, and not for blocking access to a specific 900 NPA or 976 prefix telephone numbers.
- The Company shall not terminate telephone service to its subscribers solely for the non-payment of 900 or 976 charges.
- 4. The Company shall remove billed 900 and 976 charges from an end user's bill under the following conditions:
  - a. The Company provides billing service to the 900 or 976 provider;
  - b. This is the end user's initial contact with the Company disputing 900 or 976 charges;
  - The 900 or 976 charges were incurred without the end user's consent or knowledge.
- 5. When 900 or 976 charges are removed from an end user's bill and where network facilities permit, the Company will recommend blocking service to the end user to avoid future unauthorized use of 900 and 976 services.
- If the end user refuses Blocking Services, future 900 and 976 charges will not be removed from the end user's bill unless otherwise justifiable.
  - a. If the end user refuses to pay for justified charges and after refusing blocking, the Company may initiate mandatory blocking at no charge to the subscriber.
  - b. When mandatory blocking has been imposed, access to 900 and 976 Service will be denied until outstanding charges have been paid in full.

#### AUTHORIZED CONNECTION WITH FACILITIES OF A SPECIFIED GOVERNMENT AUTHORITY

#### A. POLICE AND FIRE DEPARTMENT FACILITIES

- 1. Telephone circuits owned and maintained by the police or fire department of a state, municipality or other governmental authority and extending between premises of such customer in the same exchange may be connected with a private branch exchange switchboard or other equipment furnished to said customer by the Telephone Company. Such connection may not be used for exchange toll service except in case of public emergency.
- 2. Police radio broadcast systems owned, maintained and operated by the police department of a state, municipality or other governmental authority may be connected with a private branch exchange switchboard or other equipment furnished to said department by the Telephone Company, for radiotelephone communication with telephone stations associated with such switchboard or equipment. Such connection may not be used with any other station of the Telephone Company except in case of public emergency.

#### A. GENERAL

 Customer facilities will be connected with facilities of the Telephone Company as provided in the following paragraphs of this section. In all such cases the customer facilities will be so constructed, maintained and operated as to work satisfactorily with the facilities of the Telephone Company.

#### B. POWER, PIPE LINE AND RAILROAD COMPANY FACILITIES

- 1. Facilities of an electric power company or oil, oil products or natural gas pipe line company, or railroad company, provided primarily to communicate with points located along a right-of-way (including premises of such company anywhere in cities, towns or villages along the right-of-way) owned or controlled by such company and extending between or beyond exchange areas of the Telephone Company, will be connected with facilities furnished by the Telephone Company to the same customer, subject to the regulations and conditions herein stated in B., 1 to 9, inclusive, in addition to those specified in A. General above. Such connections will be made by means of switching or connecting equipment furnished by the Telephone Company.
- 2. Such customer telephone facilities will be connected to private branch exchange switchboards or other telephone switching or terminal equipment of the Telephone Company, located in the same or different local service area, for communication with stations and private line facilities associated with said switching or terminal equipment; provided, however, that within the same local service area, a private branch exchange switchboard or other telephone switching or terminal equipment fumished by the Telephone Company for exchange or message toll service will not be connected with telephones of the customer except telephones associated with party line right-of-way circuits requiring line termination at the P.B.X., nor with private telephone switching equipment of the customer except where such private telephone switching equipment is used exclusively for dispatching.

#### B. POWER, PIPE LINE AND RAILROAD COMPANY FACILITIES (Continued)

- 3. Facilities of the Telephone Company will be connected for exchange for exchange or message toll service with telephone facilities or the customer:
  - a. (1) In cases of emergency involving safety of life or property; (2) in addition, in cases of calls originated by railroad employees under circumstances indicating need for prompt action to secure or maintain the safety, continuity, or reliability of railroad service to the public and related to the movement of passengers, mail, property, or equipment by railroad, or the repair, maintenance, or construction of railroad rights-of-way, structures, or equipment;
  - b. the customer facilities serve locations where it is impracticable because of hazard or inaccessibility for the Telephone Company to furnish its facilities; or
  - during an interim period the customer has arranged for replacement of said customer facilities with facilities of the Telephone Company.

Customer facilities referred to in b. and c. above do not include mobile radio-telephone facilities.

- d. customer telephone facilities as specified in 1. above will be connected to private line telephone services and channels furnished by the Telephone Company to the same customer, for communications with stations associated with such private line telephone services; provided, however, that facilities of the customer will not be connected to exchange or message toll lines to form a trough connection except as specified in a., b., and c. above.
- 4. Telephone circuits of the customer extending between or beyond exchange areas of the Telephone Company, will be connected for exchange or message toll service only through manual switching equipment, or an attendant's position of dial P.B.X. equipment, furnished to the customer by the Telephone Company. Such equipment or position may be located at either or both ends or the customer's circuit.

- B. POWER, PIPE LINE AND RAILROAD COMPANY FACILITIES (Continued)
  - 5. Connection of a customer' telephone circuit as specified in 3.a.(2), b., or c. preceding may be established at either end of such circuit, but shall not be established at both ends simultaneously.
  - 6. Facilities of the Telephone Company, when connected with facilities of the customer, will not be used for communications of other than the customer, except that such facilities may be used for the communications of, and be connected with facilities furnished by the Telephone Company to, other companies which:
    - a. are operated with the customer as parts of an integrated electric power, oil, oil products, or natural gas system or railroad system under direct or common ownership or control; or
    - b. own or operate an electric power or pipe line or railroad system jointly with the customer; or
    - c. own or operate electric power or pipe line or railroad facilities interconnected with those of the customer.

Telephone Company facilities when so connected may be used for exchange or message toll communications of other companies specified in a., b., or c. preceding, including calls originated by employees of such companies, only under the circumstances set forth in 3.a. above.

- 7 Customer facilities for telephotograph, data transmission, teletypewriter, Morse, Facsimile, or remote metering, supervisory control and miscellaneous signaling will be connected to private line facilities furnished for such purposes to the same customer.
- Private line service channels will be furnished by the Telephone Company between a terminal of customer facilities within or near a telephone exchange area or local service area and a location within such exchange or local service area for connection at such location with terminal equipment furnished by the Telephone Company; provided, however, that terminal equipment not furnished by the Telephone Company may be furnished by the customer.

- B. POWER, PIPE LINE AND RAILROAD COMPANY FACILITIES (Continued)
  - 9. Equipment provided by the customer on his dircuits for the purpose of deriving telephone, teletypewriter or Morse, Facsimile, telephotograph, remote metering, supervisory control or miscellaneous signaling channels may be used, if suitable for such use, to derive such channels over private line channels furnished by the Telephone Company as provided in 8., preceding.
- C. AIRLINE COMPANIES AND FEDERAL AVIATION AGENCY
  - 1. Facilities provided by an Air Common Carrier, its authorized communications agency, or the Federal Aviation Agency to communicate with aircraft in flight may be connected, by means of connecting equipment furnished by the Telephone Company, to Telephone Company facilities located on the premises of the customer for exchange and message toll service in cases of emergency involving the safety of life or property.

#### PRIMARY BASIC LOCAL EXCHANGE SERVICE

#### **DESCRIPTION OF SERVICE**

#### **GENERAL**

- 1. Primary Basic Local Exchange Service (PBLES) is a restricted Residential Basic Local Exchange Service offering. See Service Parameters as stated on Sheet No. 6 of this tariff.
- 2. The Telephone Company only offers Primary Basic Local Exchange Service in exchanges where the Telephone Company offers Residential Basic Local Exchange Service under its Tariff M.P.S.C. No. 1(R).
- 3. Primary Basic Local Exchange Service is the furnishing of facilities for telephone intercommunication between customers within a Local Calling Area.
- 4. Primary Basic Local Exchange Service customer may purchase any unregulated calling feature on a stand-alone basis at the then current rates for that unregulated calling feature.
- 5. The provision of Primary Basic Local Exchange Service is subject to regulations specified in the M.P.S.C. Tariffs of the Telephone Company, which tariffs as they now exist or as they may be revised, added to, or superseded are hereby made a part of this Tariff.
- 6. Primary Basic Local Exchange Service is a grandfathered offering as described in Tariff MPSC No. 7R Sheets 5 and 9.1 for the Buckley, Copemish-Thomsonville, Hoxeyville, Mesick, South Boardman and Old Mission exchanges.
- 7. Primary Basic Local Service has been discontinued for the Allendale, Coopersville, Drenthe, Holland (N) and Zeeland exchanges. (N)

#### **APPLICATION**

- 1. Primary Basic Local Exchange Service is available only at locations where residential service would be available.
- 2. No more than one Primary Basic Local Exchange Service will be provided to an address.
- 3. A monthly recurring charge plus a MOU and/or a per call charge (where applicable) will apply as described in this tariff.
