LOCAL TELEPHONE EXCHANGE SERVICE

SERVICE CHARGES

A. GENERAL

1. Service charges are applicable with the establishment of the telephone service, and for subsequent changes and additions thereto as specified in this tariff.
2. Service charges consisting of one or more of the following charges may apply for new or additional service or changes in service which require the activity or work as briefly indicating under "Charges" or as specified under Application of Charges or as modified by specific Tariff items elsewhere in this tariff.

B. APPLICATION OF CHARGES

1. Establishment of Service - An establishment of service charge applies on each customer order when a new customer account is established. A customer order involving an existing account (made subsequent to establishment of the account) also has an establishment of service charge as shown under "Charges". The Establishment of Service Charge to existing accounts applies when an existing customer's order involves lines, outside plant, or other requested services for which monthly rates are established.

The Establishment of Service Charge also applies to:

Establishment of a special billing number account at the customer's request.
Change to nonpublished number service.

The Establishment of Service Charges does not apply to:

Change in grade of service.
Change in billing address
Discontinuance of nonpublished number service
Discontinuance of any service if changes in equipment are not required.
Change in classification of service (bus. or res.)

2. Line Connection Charge - A line connection charge, per line, is made for each line on which work is required by the service order; in the central office; outside plant; drop wire; or other portion of plant up to the premises served.

This charge also applies to a change in telephone number or party line assignment made at the request of the customer, restoral of service, establishment to touch calling service or move of drop wire.

4. Other Applications or Exceptions To Service Charges

- a. The charges specified herein do not contemplate work being performed by the company employees at a time when overtime wages apply due to the request of the customer nor do they contemplate work begun being interrupted by the customer. If the customer requests overtime labor being performed or interrupts work once begun, a charge in addition to the specified charges will be made equal to the additional cost involved.
- b. No service charge will apply when the service is rendered inoperative by fire or other cause beyond the control of the customer which renders the premises unfit for occupancy and service is re-established at another location. Service charges apply for transferring a temporary installation to another location.

DIRECTORY LISTINGS

A. GENERAL

1. Directory Listing regulations apply to listings in the regular alphabetical list of names of customers, commonly referred to as "white pages".
2. A listing in the alphabetical section of the directory is provided to a customer without extra charge. Listings are intended primarily for the purpose of identification and are limited to information which is essential to such identification. Directories are furnished and the Telephone Company reserves the right to refuse to insert any listing in its directories which does not facilitate directory service.
3. The length of any listing is limited to one line by the use of abbreviations when the clearness of the listing and the identification of the customer are not impaired thereby. When more than one line is required to properly list the customer, no additional charge is made.
4. The Telephone Company will refuse to list in the alphabetical section of the telephone directory any listing which does not constitute a legally authorized and adopted name, and/or any name which is likely to mislead or deceive the public as to the identity of the customer, or consisting of figures and symbols, or which is inserted for advertising purposes, or which is more elaborate than is reasonably necessary to identify the customer. The Telephone Company will withdraw any listing which is found to violate the above rule.
5. When a customer contracts for more than one individual line of the same class and at the same location, consecutive telephone numbers may be assigned to such lines and in such cases the use of more than one listing is unnecessary for the efficient handling of the service.
6. Upon written request, a customer's listing may be omitted from the directory. Connection with such non-published stations are completed only when requested by telephone number.

B. BUSINESS LISTING

1. A listing must be the name of the individual, partnership, corporation, firm, association, institution etc., to whom service is furnished; or the name of a member, officer, employee or representative thereof; or the name of another business house which the customer represents; controls or owns. Listings other than those specified herein are available only in connection with Joint User Service.
2. The listing of a service, commodity or trade name - such as "Coal; 237 W. 5th Street; 346-5376:" - appearing in the sequence of alphabetical names is not permitted.
3. When a customer is engaged in more than one line of business, only the business by which he is best known will ordinarily be included in the business designation.
4. Double name listings or the use of titles such as "Pres.", "V-Pres.", "Mgr.", etc., are not permitted - for example, "Paramount Supply Co., John Drake, Manager; 243-4365.
5. Listings of telephones in churches will not include in the same listing the name of the church and also that of its pastor or of organizations or societies associated therewith.
6. A caption listing - for example, the listing Masonic Temple under which is indented Auditorium, Banquet Room, Chapter Floor, each with telephone number - is provided only if necessary for the efficient use of the service; no additional charge is made for the caption listing. The caption must be of an essential part of the listings which follow. The names of individual are not inserted under a caption, but will be shown in their proper alphabetical sequence in the directory. Indented listings which do not materially add to the information contained in the caption or which are designed to advertise the extent of the customer's business are not permitted.

1. A listing must be the name of the customer to whom service is furnished or the name of a member of the customer's domestic establishment.
2. A listing for residence service may appear as an indented listing. In such cases, the designation "res.", "residence", "cottage", or "farm" will appear before the customer's address or telephone number.
3. The listing of a telephone in the residence of a professional man such as a physician, dentist, veterinary surgeon, osteopathic physician, doctor of divinity, etc. may include his professional degree provided, however, that the listing of only an individual name is desired.
4. The listing of a telephone in the residence of a nurse may include the word "nurse".
5. The listing of a telephone in a clergyman's residence or the church study may include the abbreviation "Rev." following the clergyman's name except that when the listing includes the professional degree "DD", the abbreviation "Rev." is not shown.

D. ADDITIONAL LISTINGS

1. Cross reference listings are available as Additional Listings when both the main and cross reference listings appear in the same alphabetical list, provided the cross reference listing is an aid in rendering telephone service and not designated for advertising purposes. As an aid to the service, cross reference listings may be provided without charge in connection with the service of Federal, State or Municipal governmental agencies.
2. Customers whose names are currently spelled in more than one way, may arrange for Additional Listings of the name as misspelled when such listings will aid the directory service.

JOINT USER SERVICE

A. GENERAL

1. Joint User Service is an arrangement whereby a person or firm - designated a Joint User - is permitted to use the service of a customer. To facilitate this use, a directory listing is provided for each Joint User.
2. Joint User Service is provided only in connection with individual line business service and private branch exchange business service.
3. The Joint User must be located in the same office or suite of offices as the customer, or in an office immediately adjacent thereto and connected therewith by passageways other than public passageways.
4. Joint User Service is not furnished in association with the service of a customer who is engaged primarily in performing service of a secretarial nature or who is in the business of renting space to transient or permanent tenants.
5. No separate ring numbers of distinctive designations are assigned for the purpose of signaling Joint Users.
6. Joint User Service must be contracted for by the original customer who is required to assume responsibility for all charges incurred by the Joint User.
7. Charges for Joint User Service date from the day the service is first rendered. The Joint User Service is automatically discontinued upon termination of the main service. The minimum charge for Joint User Service, however, is the charge for the period of one month.

B. RATES

Joint User Service, including one listing in the directory, is furnished at 1/2 the charge for one Individual Business Line, per month.

A. GENERAL

1. Combination Main Station Service applies to cases where a customer wishes to contract for a main station service at each of two separate locations (ordinarily each station will be assigned a separate telephone number) within the same exchange, so as to be able to answer calls for one main station at the other main station location or both stations at either location.
2. Combination Main Station Service is provided only in connection with individual lines (excluding coin box lines) and is furnished subject to the ability of the Telephone Company to provide satisfactory transmission and signaling arrangements and to the rate treatment outlined herein.
3. Combination Main Station Service may be employed where one station is at a business location and the other at a residence or where both stations are at either business or residence locations, but only in connection with services contracted for and used by the same customer.

B. RATES

1. Each main station is charged for at the established individual line business or residence rate, according to the classification of the service at each premises as to business or residence character.
2. In applying exchange line mileage charges, as provided for in Tariff M.P.S.C. No. 2, each main station service is considered separately and the mileage charges applicable for individual line service area assessed for each service.

A. GENERAL

(N)

Paystation Service provides telephone service to a customer-leased or owned paystation with or without coin collecting devices. A Paystation Access Line permits providers of such service to provide pay telephone service to the public.

B. DEFINITIONS

Coin Supervision - Provides signaling capability from the central office for paystations that do not have signaling capability within the telephone. This signaling capability provides operators and/or operator systems coin control.

Customer - For the purposes of this tariff, the customer is the Paystation Service Provider.

Network Interface Device - A company-provided jack or its equivalent. It is the point of connection between the Company owned wiring and wiring owned by the customer. For the purposes of this tariff, the network interface device will be installed at a location mutually agreed upon by the customer and the Company.

Originating Line Screening (OLS) - Enables operator service providers to determine whether there are billing restrictions on the exchange access line from which a call originates. OLS service delivers codes on operator assisted calls to identify calls originating from privately owned paystations, inmate locations, and hotels/motels, etc. Rates for this service are found in the appropriate interstate access tariff, when facilities and service are available.

Paystation Access Line - A basic coin transmission dial tone line. It is a line side connection from local exchange switch to the point of demarcation at the customer premises.

Selective Class of Call Screening - Enables the customer to restrict outgoing operator-handled calls, placed over the Company's network, from the service point to only those calls which are charged to a called telephone, a third number or a calling card. Selective Class of Call Screening will be provided at the customer's option, where such facilities are available.

C. RULES AND REGULATIONS

1. Paystation Service will be considered a business service for the purpose of applying the terms, rates and conditions found elsewhere in this tariff.
2. Only one paystation instrument may be connected to each Paystation Access Line. Off-Premise Extensions are not permitted.
3. The customer shall be responsible for the installation, operation and maintenance of any paystation instrument used in connection with this service.
4. Requests to Directory Assistance Service originated from paystations will be charged the applicable rate of the Directory Assistance Service Provider.
5. Directory listings may be provided under the regulations that govern the furnishing of listings for business customers.
6. Coin-free operator and emergency 911 access must be available from all paystations.

LIFELINE SERVICE

A. DESCRIPTION

1. Lifeline applies discounts to monthly recurring rates for qualifying residential customers. These discounts are applied to existing rates and charges for residential telephone service.
2. In order to be eligible for Lifeline a residential customer's annual household income must be at or below 150% of the poverty level as determined by the United States Department of Health and Human Services and as approved by the State Treasurer, or the person must participate in one of the following programs:
 - a. Medicaid
 - b. Supplemental Nutrition Assistance Program (SNAP) – Food Stamps
 - c. Supplemental Security Income (SSI)
 - d. Federal Public Housing Assistance/Section 8
 - e. Low Income Home Energy Assistance Program (LIHEAP)
 - f. National School Lunch Program's free lunch program
 - g. Temporary Assistance for Needy Families (TANF) a/k/a Family Independence Program
3. Lifeline includes the services and functionalities enumerated in by the FCC. as follows: voice grade access to the public switched network or its functional equivalent; minutes of use for local service provided at no additional charge to end users; access to the emergency services provided by local government or other public safety organizations, such as 911 and enhanced 911, to the extent the local government in an eligible carrier's service area has implemented 911 or enhanced 911 systems; and toll limitation services.
4. Other services can be provided with Lifeline at applicable rates and charges.
5. Proof of eligibility will be required for all initial Lifeline applicants and all Lifeline recipients will be required to re-certify every year.

B. REGULATIONS

1. Regulations specified elsewhere in the Company's tariffs apply to Lifeline.
2. Lifeline is available only with residence services, excluding foreign exchange service. Lifeline is limited to a single subscription per household where household is defined to be any individual or group of individuals who are living together at the same address as one economic unit. For the purposes of this rule, an economic unit consists of all adult individuals contributing to and sharing in the income and expenses of a household.
3. A miscellaneous service charge does not apply when Lifeline is added or discontinued to existing service when that is the only work being done.
4. The Lifeline plan will apply after receipt and processing of a completed Lifeline application, including documentation indicating that the household income meets the eligibility standards established above.
5. Customers of Lifeline must notify the Company of any changes which would affect qualification. Recertification of eligibility will take place on an ongoing basis. When the customer is no longer eligible for Lifeline service, the Lifeline discount will be discontinued and regular tariff rates and charges will apply.
6. As a participant in Lifeline, customers are eligible to receive toll blocking service at no charge. This service will only be provided at the customer's request. Toll blocking service is defined as a central office service that restricts access to the network. Toll blocking is provided where facilities permit and will not allow 1+, 0+, 0-, 101XXXX, 900, or interzone calls to be completed. Toll blocking does not restrict local calls, calls to intraNPA directory assistance, telephone repair service, 911, or calls to 800 or 950 numbers.
7. Local service deposit requirements will be waived for customers who voluntarily receive Toll Blocking Service.
8. Participants in Lifeline shall not be disconnected from local service for nonpayments of toll charges. In addition, The Company will not deny re-establishment of local service to customers who are eligible for Lifeline and have previously been disconnected for nonpayment of toll charges.

C. MONTHLY RATES AND DISCOUNTS FOR LIFELINE CUSTOMERS

1. The discount on the monthly rate for residential exchange service for qualified Lifeline customers shall be \$9.25 from the Federal discount program plus \$2.00 from the State discount program for a total discount of \$11.25. Credits are applied to the end user's basic local exchange service. At no time shall the total Lifeline credit exceed the sum of the end user common line charge and the basic local exchange rate. The discount on the monthly rate for residential exchange service for qualified Lifeline customers 65 years of age or more shall be \$9.25 from the Federal discount program plus \$3.10 from the State discount program for a total discount of \$12.35. Credits are applied to the end user's basic local exchange service. At no time shall the total Lifeline credit exceed the sum of the end-user common line charge and the basic local exchange rate.

D. MONTHLY RATE FOR NON LIFELINE CUSTOMERS

A rate specified in MECA's Tariff M.P.S.C No. 25 Part XVII, General applies per exchange access line to cover the costs of the Lifeline service, to the Telephone Company intrastate services as listed below:

- Business and Residence exchange services excluding Lifeline customers.
- PBX Trunk Services
- Centrex Services

The rate for business Centrex station lines will be computed based on the trunk Equivalence Table specified in the Company's Tariff M.P.S.C. No. 2.

E. TRIBAL LINK UP PROGRAM - Brimley Exchange Only (N)

1. A discount on the line connection charge is available to qualifying Lifeline customers residing on Tribal lands as defined in 47CFR §54.400(e) for the installation or transfer of services from one residential premises to another.
2.
 - a. A qualifying customer may receive a 100% reduction up to \$100 in the installation charges, or transfer of service charges, for connection at the customer's principal place of residence.
 - b. A qualifying customer may then make payments for the connection charges on a deferred schedule in which the qualifying customer does not pay interest. The interest charges not charged to the qualifying customer shall be for connection charges of up to \$200.00 that are deferred for a period not to exceed one year. Charges assessed for installation or transfer of service include any charges that the Company customarily assesses to connect subscribers to the network. These charges do not include any permissible security deposit requirements.
 - c. A qualifying customer can receive the benefits of the Tribal Link Up Program for a second and subsequent time only for a principal place of residence with an address different from the residential address at which the Tribal Link Up assistance was approved previously. (N)
