Enclosed is one copy of TAM's revisions to Michigan Central Broadband Company Tariff M.P.S.C No. 10R for filing with the Commission pursuant to PA 179 of 1991, as amended, MCL 484.2101 et seq., under Transmittal No. 4.

FCC Rule 51.705(c)(3) requires that no carrier's Non-Access Reciprocal Compensation rate shall exceed the carrier's tariffed interstate access rate in effect in the same year for the equivalent functionality.

FCC Rule 51.909(h)(1)(i) requires that beginning on or about July 1, 2020, each Rate-Of-Return (ROR) carrier shall establish interstate and intrastate terminating End Office Access Services rates such that its Terminating End Office Access Rate does not exceed \$.0000 per minute. FCC Rule 51.909(h) further provides that such ROR carrier's intrastate terminating end office access rates may not exceed the comparable interstate terminating end office access rates.

This tariff filing reduces the applicable local switching rate element to \$.0000 per minute.

C. DEFINITIONS

Provider

A telecommunications carrier, other than Michigan Central Broadband Company, that provides switched local exchange telecommunications services, or similar services, and includes wireless providers, CMRS providers, VOIP providers, and provider of telephone like service.

Conversation Minutes

Conversation minutes are measured in terms of conversation time between the calling party and called party. Calls based on conversation minutes begin when the called party answers, as determined by answer supervision, and end when either party disconnects.
