Enclosed for filing is one copy of Michigan Central Broadband Company's revisions to Tariff M.P.S.C. No. 1R pursuant to PA 179 of 1991, as amended, MCL 484.2101 et seq. This filing does the following:

1. Includes the service description and rates for "Local Calling Service Plan 1" (formerly Plan U1) which tariff provisions were formerly in MPSC Tariff No. 3(U), now being rescinded;
2. Deletes all references to "Primary Basic Local Exchange Service" which has been withdrawn;
3. Revises and increases the Establishment of Service, Line Connection, and Premise Visit charges;
4. Revises the limitations on dictionary listings and non-published listings;
5. Moves the tariff provisions from Tariff 3U on Direct Inward Dialing; Main and Extension Stations, Mileage charges, Grandfathering and Grandfathered Service, Directory Assistance, Employee Telephone Service, Temporary Suspension-Seasonal Service, and Number Retention Service.

A. APPLICATION

1. This Tariff governs the Basic Local Exchange Service of Michigan Central Broadband Company – hereinafter referred to as the Telephone Company or Company – in Exchanges in Michigan as designated herein. (C)
2. Basic Local Exchange Service is that of furnishing facilities for telephone intercommunication for Customers within a Local Calling Area. (C)
3. The provision of service under this Tariff is subject to regulations specified in other applicable the MPSC tariffs of the Telephone Company, which tariffs as they now exist or as they may be revised, added to, or supplemented by superseding issues are hereby made a part of this Tariff.

DESCRIPTION OF SERVICE

A. GENERAL

1. Local Calling Service Plan 1 provides telephone intercommunication between customers within a Local Calling Area. (C)
2. Unless otherwise indicated, the service may be used for voice or data communication. The service provides unlimited incoming local calls.
3. In addition to the Monthly Local Service Charge, for calls dialed to a station bearing the designation of a central office within an exchange identified in the Local Calling Area, the Company reserves the right to charge the following: (C)

First 2,000 Conversation minutes of use (MOU) in each month: \$0.00 per MOU. Each Conversation MOU over 2,000 in each month: \$0.05 per MOU

The Company will measure Conversation MOU from the time when the Company's switching equipment received answer supervision to the earlier of when the Company's switch receives disconnection supervision from its own switch or from the terminating switch. The Company will measure Conversation MOU to the next higher whole MOU per call. No MOU are carried forward from month to month.
4. The Company will not provide call record detail for local usage in the end user's monthly bill. The Company will provide call record detail, and the end user's request, at a charge of \$5.00 for each month requested.
5. For calls to exchanges not in the Local Calling Area, customers will be billed long distance charges. (C)
6. Touch Tone Service is included with this service.
7. Service Charges as stated in this Tariff apply. (M)

8. Calls made to a telephone number with an NPA NXX that is associated with the rate center that is within the customer's local calling area are local calls regardless of the physical location of the called party.

SERVICE CHARGES

A. GENERAL

1. Service charges are applicable to the establishment of telephone service and for subsequent moves thereto as specified in this Tariff.
2. Service charges consisting of one or more of the following charges apply for new service which requires the activity or work as briefly indicated under "Charges" or as specified under the Application of Charges or as modified by specific items elsewhere in the Tariff.

B. APPLICATION OF CHARGES

1. Establishment of Service – An Establishment of Service Charge applies to work performed by the Company in connection with receiving, recording and processing Customer requests for service, and equipment ordered to be performed or provided at the same time, involving the establishment of a new Customer account. The Establishment of Service Charge also applies to restore service in cases in which the Customer's service has been disconnected voluntarily or involuntarily for cause as permitted by law.
2. Line Connection Charge – A Line Connection Charge applies to each central office line on which work is required by a service order in the Company's central office, outside plant, drop wire, or other portion of plant up to the premises served. The Line Connection Charge applies to the restoration of service in cases in which the Customer's service has been disconnected voluntarily or involuntarily for cause as permitted by law.
3. Premise Visit Charge – A Premise Visit Charge applies to each Customer's order which requires a visit to the Customer's premises. Service work in several buildings of a Customer located on the same continuous property requires one charge per premise visit. A premises is a building, or a portion of a building or buildings, on the same continuous property occupied by the Customer. All space for offices occupied by a Customer on the same or separate floors of one building are considered as a single (or same) premises. "Continuous" property refers an uninterrupted plot of land within the same block and occupied by one Customer (i.e., a parcel of land enclosed but uncrossed by public thoroughfares; railroad tracks, rivers and alleys are not public thoroughfares). "Building" refers to a structure on one foundation or two structures on separate foundations with a common wall or abutting walls with ready access from one structure to the other by means of doorways or permanent openings through the intervening wall or walls. Structures in the same or different block occupied by one Customer and connected by passageways shall be considered as the same building if the passageway is actually used as a continuation of the space in the two buildings and not principally used as a walkway.

Where such a line is other than the section line or one-quarter or one-half mile from a section line, the location of the boundary line with respect to the section line will be shown in feet or fractional miles on the Tariff map sheet.

MAIN AND EXTENSION STATIONS

A. GENERAL

1. Extension stations are normally limited to the same exchange as the associated main station service. Extension stations in a different exchange are provided subject to the availability of facilities and where satisfactory transmission and operation can be provided using normal facilities.
2. Central office lines extended between different switching equipment or between switching equipment and a telephone instrument are classified as extension stations.
3. Separate telephone numbers or other distinctive designations are not assigned to extension stations nor is code ringing permitted. Extension stations are not listed and no additional free listings are allowed in connection with the main station on account of extension stations.
4. Extension stations must be located on the premises of the Customer (or of the joint user on business services) and are restricted to Customer's use (and the use of members of the domestic establishment or employees), except that in the case of individual line subscriber service extensions may be located on another's premises with the understanding that the service is to be used for incoming calls only, and if a separate exchange service is subscribed for at the other premises. A. GRANDFATHERING

This section addresses cases in which Grandfathered service offerings are continued only for existing Customers at existing locations. The rates for grandfathered services are subject to change in the same manner and to the same extent as regular service offerings. Where a new Customer takes over existing telephone service, with or without a change in directory listing, where the Customer initiates a change in class of service or where there is a break in the continuity, the “grandfathered” service is no longer available. The renting or leasing of the premises on which the service is provided to someone other than the existing Customer voids the furnishing of the grandfathered service, whether or not the telephone service remains in the name of the original Customer.

B. GRANDFATHERED SERVICES

COMBINATION MAIN ACCESS LINE SERVICE

1. GENERAL

- a. Combination Main Access Line Service applies to cases where a Customer wishes to contract for an access line at each of two separate locations (ordinarily each line will be assigned a separate telephone number) with the same exchange, so as to be able to answer calls for one access line at the other access line location, or both access lines at either location.
- b. Combination Main Access Line Service is provided only in connection with individual lines and is furnished subject to the ability of the Company to provide satisfactory transmission and signaling arrangements and to the rate treatment outlined herein.
- c. Combination Main Access Line Service may be employed where one line is at a business location and the other at a residence or where both lines are at either business or residence locations, but only in connection with services contracted for and used by the same Customer.
- d. Combination Main Access Line Service is grandfathered as of November 1, 2000.
- e. Each access line is charged at the established individual line business or residence rate, according to the classification of the service at each premises.

C. EXEMPTIONS

1. Residence and business service (including a Centrex or AIOD equipped PBX station) are exempt from the charges for Directory Assistance Service when a user (or the principal user of a business service) is unable to use a telephone directory because of physical or mental limitations.
2. To obtain an exemption, the customer provides the name, address, telephone number and nature of the limitation for the individual requiring the exemption. A certificate of Directory Assistance Charges Exemption is required for each residence or business line to be exempted.
3. Information contained on the exemption certificate will be treated as confidential by the company.
4. The customer shall notify the company when the need for an exemption no longer exists. (N)

EMPLOYEES' TELEPHONE SERVICE

A. GENERAL

1. Residential local telephone exchange service is available without charge to employees currently employed who have at least one year net credited service with the telephone company in connection with telephone service in their residences. It is also available to retired employees having at least 20 years of employment service with the company.
2. Residential local telephone service is not available without charge to employees who reside in boarding houses, rooming houses, or in foreign exchange areas. It is also not available to employees having businesses in their residences.
3. The primary listing provided with the service is permitted only in the name of the employee, except that the listing of a married woman employee may be in her own or in her husband's name.
4. Additional listings and foreign listings are provided at the rates specified in other sections of this tariff.

B. RATES

1. There shall be no charge made for service connection charges such as installations, moves and changes, or for nonrecurring charges.
2. With the exception of management personnel and retired employees, the employee shall pay full rates for all other service except those outlined in items A.1 and B.1 above.
3. Retired employees shall receive up to a maximum of \$25.00 per month for toll services at no charge provided by Alpha Long Distance. No discount or credit is available if the retiree selects a different long distance service provider.

TEMPORARY SUSPENSION – SEASONAL SERVICE

GRANDFATHERED SERVICE – NO LONGER AVAILABLE

A. GENERAL

(N)

1. Upon request, local exchange telephone service may be temporarily suspended. Service temporarily suspended enables a customer to continue a listing in the directory, reserve their telephone number and plant facilities for future use, and avoid encumbrance of a service connection charge at the time service is activated. Temporary suspension of service offers a customer reduced rates for period where services is not needed, such as inactive seasonal periods or times a customer leaves on vacation.
2. The total charges applicable for the initial period will apply even if the service is suspended prior to the termination of the initial service period for the convenience of the customer. The temporary suspension rate will not become effective until the initial service period has expired.
3. When a customer's service has been temporarily suspended and reconnection of the service is requested, the minimum charge will be that for one month's service, before the service can again be given the temporary suspension rate treatment. However, the foregoing is for rate purposes only and does not preclude the customer from having their actual telephone service temporarily suspended during this minimum charge period.
4. Temporary suspension of service is not available to foreign exchange service, cable carrying charges in lieu of mileage charges, PABX services, or during any service period required by a contract between the utility and the customer.
5. The minimum period of temporary suspension is one month.
6. The maximum period of temporary suspension is eight months in each annual period.

B. TEMPORARY SUSPENSION OF ENTIRE SERVICE

1. A customer for any grade of local business or residence service may temporarily suspend the entire service furnished. The rate during the period of suspension of business and residence service shall be 50% of the total monthly exchange local service charges.
2. The customer is entitled to one restoral of service annually with charge. The second occurrence on an annual basis will be billed at the applicable service connection charge.

1. Number Retention Service is provided at the request of the customer. This service enables the customer to continue to be a listing in the directory and reserves the telephone number for future use. **Telephone service is discontinued** during the application of Number Retention Service. Customer calling card remains active. Customer personal alarm circuits, etc., connected to company facilities will not operate.

B. CONDITIONS

1. A service charge is applicable at the time Number Retention Service is initiated.
2. A monthly charge is applicable for each month or part of a month of Number Retention Service.
3. The customer may choose to have service suspended for an unlimited period of time.

All toll calling plans (Inter- and Intra-LATA) **will be** discontinued at the time Number Retention Service is initiated, unless otherwise requested by the customer, and are automatically restored when Number Retention Service is ended. No long distance carrier toll plan service charges would apply.
