2.5 Payment Arrangements, Cont'd.

2.5.2 Payment for Service

A. Facilities and Service Charges

The Customer is responsible for the payment of all charges for facilities and services furnished by the Company to the Customer and to all Users authorized by the Customer, regardless of whether those services are used by the Customer itself or are resold to or shared with other persons.

B. Taxes

The Customer is responsible for payment of any sales, use, gross receipts, excise, access, or other local, state and federal taxes, charges or surcharges (however designated) (excluding taxes on Company's net income) imposed on or based upon the provision, sale, or use of the Company's services.

2.5.3 Billing and Collection of Charges

- A. The Company shall render a bill during each billing period to every Customer. Date of rendition of the Company's bill for service shall be the 1st of each calendar month. The final payment date shall be the 22nd day of the current month. The billing period shall be monthly unless otherwise specified in Customer's agreement of service. (C) (C)
