Enclosed is one copy of Winn Telecom's Tariff M.P.S.C. No. 25(R) revisions for filing with the Commission pursuant to Public Act 179 of 1991, as amended, MCL 484.2101 et seq.

The tariff revision substitutes a reference to the switched access rates set forth in the Company's Tariff F.C.C. No. 1 in place of specific rates to clarify that the intrastate switched access rates are the same as those interstate rates set forth in Tariff F.C.C. No. 1 and in effect, reduces the terminating end office local switching rate.
