Dear Ms. Ancona:

Enclosed is one copy of Midway Telephone Company's (Midway) Tariff M.P.S.C. No. 1(R) revisions for filing with the Commission pursuant to Public Act 179 of 1991, as amended, MCL 484.2101 et seq.

This filing reflects the following changes in the Company's rates and service offerings: (1) an increase in residence 1 party line rates to \$30.00 per line per month; (2) an increase in single line business rates to \$32.00 per line per month; (3) an increase in multi-line business 1 party line rates (6 or fewer lines) to \$25.80 per line per month; (4) an increase in multi-line business 1 party line rates (7 or more lines) to \$23.30 per line per month; (5) the elimination of an "educational" access line rate; (6) the elimination of a PBX trunk access line rate; (7) a rate decrease in several "Safety+net Bundled Phone and Internet Offerings"; and (8) the introduction of two additional "Safety+net Bundled Phone and Internet Offerings"; and (9) the elimination of obsolete provisions for touch call service because the functionality is a new standard feature in each access line.

The effective date of these tariffs is October 1, 2017.

### SAFETY+ net BUNDLED PHONE AND INTERNET OFFERING

**EXCHANGE:** Applicable to All Exchanges

- The Company is offering a bundled local telephone exchange and internet access service offering. This service includes the following features and functionalities:
  - Unlimited and untimed local calling to the following local exchanges: Watton/Covington/Sidnaw (355), Golden Lake (472) and Trout Creek/Kenton (852).
  - Unlimited incoming intrastate and interstate long distance or interexchange calls
  - Access to emergency service 911 calls
  - Access to Directory Listing Number Services 411 calls

  - Access to 211/711/811 calls
    Voice grade access to the public switched network

  - Dual tone multi-frequency signaling or its functional equivalent (Touch Tone service)
    Single-party service or its functional equivalent
    "1 plus the number" toll service is restricted/blocked on outgoing calls. Outgoing toll calls may be made only on a "dial-around" basis using a long distance carrier's access code.
  - Jamadots High Speed Internet Service at the speeds and rates described below.

  - 3. This offering is only available where facilities exist to offer one or more of the Jamadots High Speed Internet Plans. Not all plans are available in all areas.
